

Important Tax Information for Family Child Care Providers

Taxes are not withheld from your State checks. You are required to pay income taxes on the money you receive to care for children. You will receive a 1099 form from the state of WV in January for subsidized payments you received during the previous year. You can find more detailed information regarding this on the "Important Tax Information" sheet you were given in Step 3 or on the "Provider Information Sheet" form you were given in Step 1.

Behavior Support Specialist Corner

Brain Development is a complicated subject often talked of in early care and education. We hear terms such as neural connections, synaptic gaps, and so on. We talk of how experiences build these pathways in the brain. The following example is meant to illustrate how these pathways are constructed and utilized.

My son brought home a stray puppy and made a bed for it on the front porch. Our neighbors 'adopted' this puppy also and began feeding it treats when they arrived home in the evenings. When the neighbors red car came down the lane, the dog would leave the porch and run to get its treat. Over time, and through repetition, a 'pathway' was formed through my yard and into the neighbor's. The dog's use of this 'pathway' was automatic; it saw the red car, left the porch, and headed for the neighbor's house, always following along the 'pathway'.

This helps in understanding a child's persistent use of behaviors. Over time and through repetition the child's thoughts, perceptions and interpretations about a given event 'wear' a neural 'path' in the mind. When an event presents itself, the child's response is automatic. He is not considering different ways to the goal. There may be multiple options available, many of them much more effective, but the child follows the 'path' in the mind.

It is hard to stop using paths. We can scare the child off the path, but now have added more anxiety to his life. We could inflict pain, but again, in the effort to change we teach that inflicting pain on others is the way to solve problems. Is that a lesson we want to teach?

Getting back to the dog; we could have hit, kicked, shocked or scolded her. Probably could have changed the dog's behavior somewhat, but we don't treat dogs that way. We simply moved the dog's bed. You could say we changed the dog's perspective; her point of view. Now she runs along the driveway to the neighbors.

Our job is not to stop a child's behavior. It is to change the child's perspective; to help the child see an event from another point of view. When we do this effectively, the child will make the new path.

WVU Eye Institute: Vision Screenings for 3 & 4 year old Children

Small Office Home Office (SOHO) Community Express Loan Program

Are you in need of a working capital business loan but don't have the collateral required to secure it? The U.S. Small Business Administration has a loan program called Small Office Home Office (SOHO) Community Express which provides funding that can be used for working capital, machinery and equipment, inventory or business expansion. The loan comes in increments of \$5,000, \$10,000 or \$15,000 and is unsecured.

The application process requires no collateral, tax returns, business plans, or personal or business financial statements. Loans are funded for a seven-year term with no pre-payment penalty and have a variable interest rate of Prime plus 4.75 percent (10.75 percent as of June 14, 2005). The loan requires a packaging fee of \$475 which is refundable if the loan is not approved, and tax deductible if it is approved.



To be eligible, the applicant must operate a for-profit business. Applicants need to provide a copy of their driver's license, know their federal tax ID or social security number, have a business checking account, and possess a green card if a registered alien, at the time of application. To be considered for a loan, applicants must have good credit and not have defaulted on a prior government loan (i.e. student loan); be delinquent on child support payments; or have an IRS tax lien filed against them or their business.

Technical assistance providers are located throughout the state and available to process loan applications. You must bring a picture ID to all Trainings.
