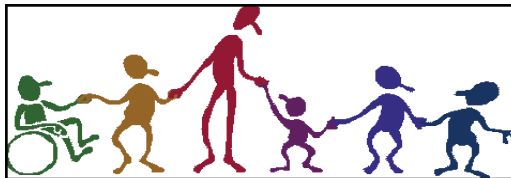
fresh perspective is all it takes to get a

# Infant/Toddler Corner by Sue Knisely

All babies and toddlers need positive early learning experiences to foster their intellectual, social and emotional development. This is crucial in laying the foundation for later school success.

Babies and toddlers that live in high-risk environments need additional support to promote their healthy growth and development.

Babies and young children thrive when quality care is given. Quality care is given by **competent** adults who have an **understanding** and **honest** nature toward the children and their parents. The care giver needs to be responsive in their relationships. Therefore, it is essential that primary care giving is taking place. That means that one caregiver has the responsibility for four children each. Primary care giving is a requirement in our state regulations. Positive attachments will be made that support healthy social-emotional development. These relationships form the foundation of mental health for infant, toddlers and preschoolers. This in turn promotes healthy social and emotional

development and prevents mental health problems at a later age. The corollary of this is healthy, educated and productive adults.

I, along with others in the Early Childhood field, feel that your job in the early childhood field is a very important career, second above being a parent.

**Quality care** for infants and toddlers is what The West Virginia Infant/Toddler Professional Development Program (WVIT) is all about. If you are an early childhood professional in a Family Child Care Home, Center, or

Facility of children ages birth to 35 months for at least 20 hours per week, and are registered with S.T.A.R.S. you are eligible to take the WVIT program. It covers all of the core knowledge and competency areas of S.T.A.R.S. After completion of the sessions, you will re-

ceive **50 hours of training credit**. Six of those hours are spent onsite with you as you are delivering care to the children. Directors of child care centers must attend an **Administrator's module** before sending staff. The next WVIT Class will begin in March. It will be held in the Logan area, if there are at least five registered. If not, it will be held in Cabell County.

## 32 Hours of Credit Available for Completing Early Care and Education Modules

Components of Quality Care and Education Module trainings are being offered by Link CCR&R beginning October 2, 2008 at the Link Office, in the 2nd floor Training Room, 611 7th Ave., Huntington. This training is an eight week course that runs consecutively over eight Thursdays from 12:00-4:00. The Training Dates are as follows: October 2, 9, 16, 23, 30, November 6, 13 and 20. The trainings are for providers working with children ages 2 1/2 to 5 years of age. Providers will receive thirty-two (32) hours of professional development for success-

fully completing the entire eight week course, as well as resources to use in their early childhood programs. A requirement of these training modules is a pre-and post-on-site visit by the Training Specialist with each provider enrolled in the training. **Registration Deadline is Friday, September 26.** Participants need to attend all scheduled sessions. Providers must be on the participant list in order to attend these sessions. **No walk in or stand by participants will be accepted and there will be no waiting list for individual sessions.** The training

Modules are: Extreme Make-overs-Space & Furnishings, Not Just Routine, For the Love of Literacy, Implementing Your Curriculum, Recipe for Relationships, Building Blocks: A Program's Structure, Including All Children: Provisions for Children with Special Needs and Communication is the Key. ## IMPORTANT TRAINING INFORMATION

### Training Rules for Link Training Sessions

1. All trainings begin promptly at the scheduled time. We expect you to arrive before the session begins. If you miss 15 or more minutes during the course of any training session, you will not receive credit for that training.

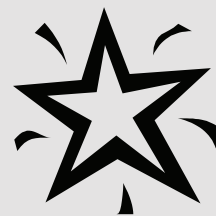

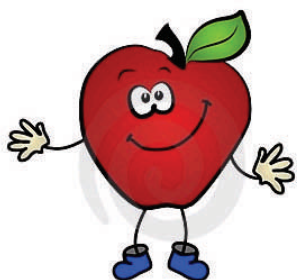

The Apprenticeship for Child Development Specialist (ACDS) Program is now offering the Ann Nutt Scholarship.

The scholarship is available to one Apprentice in each of the R&R Regions. This scholarship has been created in honor of Ann Nutt, an exemplary model of an early care and education professional. Those that worked with her feel honored to have spent that time with her and to have gained so much knowledge from her. Sadly, Ann lost her battle with breast cancer at the age of 52 on October 16, 2006. Ann was an active member of the Governing Board of WVAYC and ACDS. She served as the WV State Rep. to NAEYC Affiliate Council. She was an ACDS Instructor of Instructors and assisted other states in establishing this training program, including the training of instructors in Alaska. She helped in the creation of numerous programs for superior child care including the Development of WV Early Childhood Core Knowledge/Competencies and the Early Learning Standards Framework's (ELSF's). Ann assisted in creating the Charleston Area Medical Center's Lighthouse Child Development Center. She was a member of the state leadership team working to implement WV Pre-K. She was responsible for planning and implementing the new Infant/Toddler Training System (WVIT). Ann was great leader in the field and it is with honor that the ACDS Program is able to provide Apprentices with this opportunity. ### Family Child Care Provider Grants

Family Child Care Providers are eligible to apply for grants of up to \$250. Grants can be used to purchase resources required in regulations or curriculum materials.

We also have the following items in stock: First Aid Kits, Fire Extinguishers, Flash Lights, Digital Ear Thermometer, Carbon Dioxide and Smoke Detectors.

You must turn in receipts for the money you spend. Failure to do so will make you ineligible for future Family Child Grants and other grants that may become available through Link.

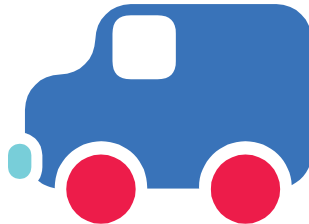
