WV STARS would like to recognize Shelia Hale of Culloden, West Virginia for receiving the West Virginia Training Certificate in Early Care and Education. The certificate was presented to Shelia on June 3, 2010 at the office of River Valley Child Development Services in Huntington by WV STARS State Coordinator Natalie Snider. Present to witness the award of the West Virginia Training Certificate in Early Care and Education (WVTECE) were the Link Early Childhood Professional Development Team, Nikki Rabel, Kerry Carnegie, Shannon Taylor, Kathy Meadows, Jennifer Conkle and Virena Elkins. Shelia is currently the Lead Teacher in a Preschool classroom at My Family Daycare and Preschool in Hurricane, WV.

Shelia was awarded the certificate only moments after completing a training titled *Under Surveillance: Observing Children*, a training that had originally been cancelled when not enough participants were registered to attend. When word spread that completion of this session provided Shelia with the remaining two training hours that she needed to meet the requirements of the WVTECE, Early Childhood Specialist Kerry Carnegie offered to provide the training to Shelia one-on-one. Without completing this session, Shelia would have had to wait until later in the summer to achieve enough hours in child Observation and Assessment to receive the certificate. Shelia began working towards obtaining the West Virginia Training Certificate in Early Care and Education in October 2007 after first learning of the certificate from previous River Valley

Child Development Services employee Lisa Ertl. Since that time, she has completed over 180 hours of professional development.

Shelia states that working towards the certificate has been a challenge for her but she believes that the time she has invested is well worth it. "It is better for the staff, better for the center, better for the children, and better for the community," she indicates. Shelia shares that the

biggest challenge to achieve the certificate was to complete hours in Child Observation and Assessment, an area of training that she believes is difficult to find.

Participating in the Apprenticeship for Child Development Specialist Journey person training has been the most valuable for Shelia Hale. Since completing the ACDS program in May of 2000, Shelia has only missed three Journey person trainings that have been offered. Her favorite training topics focus on curriculum ideas that provide her with hands-on activities to do with the children. Shelia has plans to continue her education and experience in the field of Early Care and Education. She plans on obtaining her Associates Degree in Child Development in the future and would like to become a Family Child Care Provider and operate her own facility. Her advice for other professionals in the early care and education field who are working on obtaining the West Virginia Training Certificate in Early Care and Education is, "Keep going." She also adds "If you are not working towards it-start." Congratulations Shelia. Your dedication to the continuation of your education and the children and families you serve is inspiring.

### Important Information: Two New Changes to the WV Code Which Will Affect Child Care

#### The Revised WV Code §49-2B-3 Sec. (I) reads:

(i) Any child care service that is licensed or receives a certificate of registration shall have a written plan for evacuation in the event of fire, natural disaster or other threatening situation that may pose a health or safety hazard to the children in the child care service.

(1) The plan shall include, but not be limited to: (A) A designated relocation site and evacuation; (B) Procedures for notifying parents of the relocation and ensuring family reunification; (C) Procedures to address the needs of individual children including children with special needs; (D) Instructions relating to the training of staff or the reassignment of staff duties, as appropriate; (E) Coordination with local emergency management officials; and (F) A program to ensure that appropriate staff are familiar with the components of the plan.

(2) A child care service shall update the evacuation plan by December 31, of each year. If a child care service fails to update the plan, no action shall be taken against the child care service's license or registration until notice is provided and the child care service is given thirty days after the receipt of notice to provide an updated plan.

(3) A child care service shall retain an updated copy of the plan for evacuation and shall provide notice of the plan and notification that a copy of the plan will be provided upon request to any parent, custodian or guardian of each child at the time of the child's enrollment in the child care service and when the plan is updated.

(4) All child care centers and family child care facilities shall provide the plan and each updated copy of the plan to the Director of the Office of Emergency Services in the county where the center or facility is located.

#### The revised WV Code §49-2B-8(c) reads:

(c) Before issuing a license, or approval, the secretary shall investigate the facility, program and persons responsible for the care of children. The investigation shall include, but not be limited to, review of resource need, reputation, character and purposes of applicants, a check of personnel criminal records, if any, and personnel medical records, the financial records of applicants, review of the facilities emergency evacuation plan and consideration of the proposed plan for child care from intake to discharge.

## Behavior Consultant Corner, by Shannon Taylor

Ah, summer!! It's time once again for ice cream trucks, running through sprinklers, eating watermelon, wading in creeks, catching fireflies, sipping lemonade, and splashing in puddles after the rain! Your mission this summer, should you

choose to accept it, is to get those kids outside!! Not only is fresh air just good for the soul, but playing outdoors has many other benefits for children that can drastically reduce challenging behaviors. Outdoor play promotes investigation, creativity, reasoning, problem solving, science skills and math skills, all of which can help children improve social interactions with their peers. Physically, outdoor play helps build muscles, develop coordination and strengthen the immune system, not to mention the burning

of excess energy and the way it can help children relax after a long day of play. In order to help children truly enjoy their outdoor

experiences, don't forget the sunscreen (reapply every 2 hours while outside\*) and be sure to keep them well hydrated with frequent breaks for water!

Here are a few activities to try when encouraging children to play outdoors:

Not only is fresh air just good for the soul, but playing outdoors has many other benefits for children that can drastically reduce challenging behaviors.

1. Take wooden blocks outside and help children build a fort for wayward frogs or lizards.
2. Plant a garden and teach the children how to properly care for it.
3. Go on a scavenger hunt... be sure to give the children magnifying glasses and binoculars to make the excursion extra memorable!
4. Find stumps and stones on which the children can practice their balance.

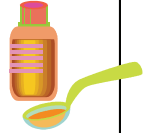
The next Director's Council Meeting and training will be held in August. We will be continuing our **Employment and Labor Law Series**. More information will be e-mailed soon.

## FUN IN THE SUN

### Babies under 6 months:

The two main recommendations from the AAP to prevent sunburn are to avoid sun exposure, and dress infants in lightweight long pants, long-sleeved shirts, and brimmed hats that shade the neck to prevent sunburn. When adequate clothing and shade are not available, parents can apply a minimal amount of sunscreen with at least 15 SPF (sun protection factor) to small areas, such as the infant's face and the back of the hands. If an infant gets sunburn, apply cold compresses to the affected area.

### For All Other Children:

- \*The first, and best, line of defense against the sun is covering up. Wear a hat with a three-inch brim or a bill facing forward, sunglasses (look for sunglasses that block 99-100% of ultraviolet rays), and cotton clothing with a tight weave.
- \*Stay in the shade whenever possible, and limit sun exposure during the peak intensity hours - between 10 a.m. and 4 p.m.
- \*On both sunny and cloudy days use a sunscreen with an SPF of 15 or greater that protects against UVB and UVA rays.
- \*Be sure to apply enough sunscreen - about one ounce per sitting for a young adult.
- \*Reapply sunscreen every two hours, or after swimming or sweating.
- \*Use extra caution near water and sand (and even snow!) as they reflect UV rays and may result in sunburn more quickly.

# Infant/Toddler Corner by Paula Stewart Hellos & Goodbyes

Drop off and pick up time can be most stressful for infants/toddlers and their parents. You, the infant caregiver, can be a big help in easing this transition time. Consider what **ITER'S - R** has to say about the issue. "Parents should enter the area used for their child's care at greeting and departure times." Some sound reasoning supports this practice. As "primary monitors" of their children's experience in childcare settings parents need to experience the environment on a regular basis to enable them to determine

if the program is meeting their child's needs. Parents who enter their child's environment can see their friends, space, materials and displays. It also gives them an opportunity to see what a great job you are doing with their children. Drop off and pick up time can serve as a time to convey information and suggestions. When parents enter the classroom or FCC Home shared experiences between the child and the parent are increased and the child gets the message that is an "OK place to be?". Safety is another issue that is addressed; when parents turn their children over directly to the child's teacher the possibilities of the child becoming "lost" are greatly reduced.

### Here are a few tips to help you, the parents and infants/toddlers survive the transition into drop off and pick up time.

Sometimes transition times are quite stressful for both the child and the parent. Toddlers especially may find the transitions of arriving and leaving very stressful and may cry. Help the parent and child develop hello and goodbye rituals that will help ease this transition.

Be proactive and suggest that the parent and child have "rehearsal visits" to your room or home to help prepare to begin child care. First try a visit where the parent is in the room with the child and does all the routines (feeding, diapering, and playing with the child). Next, the parent and child come together

again but the caregiver performs the routines. The third step is to leave the child for short periods of time. Gradually increase the amount of time the parent is gone. Show respect for the child's grief and don't be too quick to distract the child or give him/her the inaccurate message that it is not okay to be angry or sad. Reassure the child that Mommy/Daddy misses them to and that you are there to take good care of them. Let the child know it is hard for them to say good bye in the morning. This is a great opportunity to help other children in the classroom identify emotions. You may say something to the effect: Ashley is crying because she is sad that her Mommy left. I am trying to make her feel better"

Having a transitional object such as a "lovey" or picture of Mommy and Daddy can help the toddler keep the connection with their parents during the day.

Help parents understand that if a child cries when she is picked up she may be experiencing "Miss America Syndrome".....or at least something similar to what beauty contestants experience. Think of all the activities and competitions "Miss America" experiences all the while smiling and holding it all together. The moment arrives when the crown is placed on her head she breaks down and cries. Now she is safe and the prize is hers. Similarly, an infant in child care has been fine all day with the group, now with Mommy and/or Daddy feels safe enough to let down and cry or be cranky.

Remember, this will not last forever and most infants and toddlers adjust after awhile and begin to move enthusiastically looking forward to all that is in store for them that day.

## Early Care & Education Modules by Kerry Carnegie

Providing care for young children is more than just watching children, it's a profession. Participating in the Components of Quality Care & Education (CQCE) modules puts you on the right track toward becoming the type of child care provider that you would want caring for your own children. The CQCE modules can offer learning opportunities from room arrangement to conflict resolution strategies, from building partnerships with families to including children with special needs. Participating in the CQCE modules is the perfect opportunity for providers to become better child care professionals.

The Components of Quality Care & Education Module Trainings are being offered by Link CCR&R. This training is an eight week course for child care providers working with children ages 2 ½ to 5 years of age. Each module is a 4 hour training in which participants gain knowledge in several core competencies. The modules are designed to provide resources to providers and to enhance their knowledge and skills in child development. Upon completing the eight week course, providers will receive thirty two (32) hours of professional development and resources to be used in their early childhood programs. Requirements for these training modules include a pre and post on site visit by the training specialist and every participant **must be registered with the West Virginia State Training and Registry System (S.T.A.R.S).**

This quarter the sessions will be held at Forrest Burdette in Hurricane. Registration deadline is Thursday, August 5.

Participants must attend every session and no walk in or stand by participants will be accepted and their will be no waiting list for individual sessions.

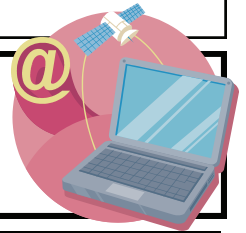

## What is the West Virginia Training Certificate in Early Care and Education?

The West Virginia Training Certificate in Early Care and Education is a certificate offered to WV STARS Career Pathway participants who have attended an extensive amount of training hours in a variety of content areas. In order to be eligible for the WVTCECE, an individual must be credentialed on the Career Pathway and have attended 120 clock hours of WV STARS Registered Training while possessing a Career Pathway Credential. The training hours must be reflected on the Professional Development Record and be completed in a variety of Core Knowledge Content Areas. Recipients must complete 20 clock hours of training in each of the following Core Knowledge Content Areas: Area 1 Child Growth and Development, Area 2 Health, Safety and Nutrition, Area 3 Positive Interactions and Relationships, Area 4 Curriculum, and Area 5 Child Observation and Assessment. Along with the 100 clock hours completed in the first five Core Knowledge Content Areas, an additional five hours of training in each of the following areas must be completed: Area 6 Family and Community, Area 7 Program Management, and Area 8 Professionalism. An additional five clock hours of training must be completed in any of the eight Core Knowledge Content Areas.

Family Child Care Providers are eligible to apply for grants of up to **\$250**. Grants can be used to

purchase resources required in regulations or curriculum materials. We also have the following items in stock: First Aid Kits, Fire Extinguishers, Flash Lights, Digital Ear Thermometers, Carbon Monoxide and Smoke Detectors. You must turn in receipts for the money you spend. Failure to do so will make you ineligible for future Family Child Care Grants and other grants that may become available through Link. 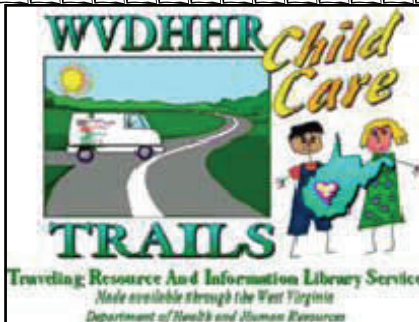
